

PILOT FLYING J COFFEE AND CASH GIVEAWAY

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Pilot Flying J Coffee and Cash Giveaway ("Sweepstakes") is sponsored by Pilot Travel Centers LLC, 5508 Lonas Drive, Knoxville, TN 37909 ("Sponsor") and is administered by Prize Logic, LLC, 25200 Telegraph Rd., Suite 405, Southfield, MI 48033 ("Administrator").

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on May 4, 2018 at 12:00 PM Eastern Time ("ET") and ends on June 28, 2018 at 11:59:59 PM ET ("Sweepstakes Period"). The Sweepstakes includes the following eight (8) entry periods (each, an "Entry Period"):

Non-winning entries will carry forward into subsequent Entry Periods. The Administrator's computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the forty-eight (48) contiguous United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void in Alaska, Hawaii, and where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant must visit <https://coffeeandcashgiveaway.com> ("Website"), enter his/her valid e-mail address, and follow the instructions to affirm that he/she is at least eighteen (18) years of age, is a resident of the forty-eight (48) contiguous United States or the District of Columbia, and has read and agrees to be bound by these Official Rules to receive one (1) entry into the Sweepstakes. If the entrant does not have a Pilot Flying J account linked to his/her e-mail address, the entrant will be required to register by entering the information requested on the registration form, which may include, without limitation:

his/her complete first and last name (initials are not permitted), date of birth, address, city, state, ZIP code, and telephone number. If the entrant does have a Pilot Flying J account linked to his/her e-mail address, he/she will be required to provide his/her account number or phone number. After completing registration, each day during the Sweepstakes Period, the entrant may visit the Website and submit his/her valid e-mail address used to register to receive one (1) additional entry into the Sweepstakes.

In-App Bonus Entries: An entrant may, using his/her Smartphone, download the myPilot app (“App”) from the app store (if he/she does not already have the App) and follow the instructions to locate the “Coffee & Cash” offer (“Offer”) in the “my Offers” section, and save the Offer in the App. An entrant will receive two (2) bonus entries by saving the Offer in the App.

Mail-In Entry: To earn bonus entries without using the App, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY) on a 3½”x5” card (“Mail-In Entry”) and mail it with sufficient postage to: the Pilot Flying J Coffee and Cash Giveaway, P.O. Box 251328, West Bloomfield, MI 48325. All Mail-In Entries must be postmarked by and received by the dates indicated in the chart above, in order to be eligible. Entrant will earn two (2) bonus entries for each Mail-In Entry.

Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries mailed in an envelope or sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Social Media Bonus Entries: An entrant may follow the instructions at the Website to share on Facebook and/or Twitter. Upon clicking the button to share the Sweepstakes on Facebook or Twitter, a message with a unique link will be posted to the entrant’s choice of his/her Facebook Wall or Twitter Feed (“Invitation Post”). An entrant’s friend/follower must click on the unique link in the Invitation Post and complete and submit the registration information requested and enter the Sweepstakes, after which the original entrant will receive one (1) bonus entry (each a “Social Media Bonus Entry”). An entrant will receive one (1) Social Media Bonus Entry for each friend/follower who completes registration by following the unique link in his/her Invitation Post for up to five (5) total Social Media Bonus Entries per entrant per social media platform (ten [10] total) during the Sweepstakes Period. The Sweepstakes is in no way sponsored, endorsed, or administered by, or associated with, Facebook or Twitter. By using Facebook and/or Twitter to participate in the Sweepstakes, an entrant releases Facebook and Twitter from any and all liability.

IMPORTANT: If using a mobile device to participate in the Sweepstakes, data rates may apply. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless providers’ pricing plans.

Limit: Limit one (1) standard entry per entrant per day at the Website during the Sweepstakes Period. Limit two (2) In-App Bonus Entries per day (regardless of method of bonus entry) during the Sweepstakes Period and ten (10) Social Media Bonus Entries (five [5] per platform) per entrant during the Sweepstakes Period. For purposes of the Sweepstakes, a “day” is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day, except for May 4, 2018, when a day will begin at 12:00 PM ET and end at 11:59:59 PM ET. If an entrant attempts to enter more than once per day, all entries after the first entry will be invalid.

- 4. RANDOM DRAWINGS:** On or about each Drawing Date listed in Section 1, the Administrator will randomly select one (1) potential weekly prize winner from all eligible entries received during the applicable Entry Period together with non-winning entries carried forward from the previous Entry Period(s); on or about July 10, 2018, the Administrator will randomly select one (1) potential grand prize winner from all eligible entries received during the Sweepstakes Period. The winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
- 5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**
- A. Grand Prize (1):** The grand prize is a \$10,000 check made payable to the winner (“Grand Prize”). One (1) Grand Prize will be available in the Sweepstakes. The ARV of the Grand Prize is \$10,000.

May be used up to balance on card only to buy goods or services at Pilot Travel Centers LLC, Flying J and Pilot Convenience Stores (collectively “Pilot”) and authorized vendors/affiliates of Pilot. Not redeemable for cash unless required by law. May not be used for lottery, money orders, tobacco products, or payment on a Pilot account. Not a credit or debit card, asset account, or deposit account. Card will not be replaced or replenished if lost, stolen, or used without authorization. CARDCO CII, Inc. is the card issuer and sole obligor to card owner. CARDCO CII may delegate its issuer obligations to an assignee, without recourse. If delegated, the assignee, and not CARDCO CII, will be sole obligor to card owner. Purchase, use, or acceptance of card constitutes acceptance of the terms state on the card and agreement to hold Pilot harmless. For balance and other inquiries, go to www.pilotflyingj.com or call (800) 562-6210. Eight (8) Weekly Prizes will be available in the Sweepstakes (one [1] per Entry Period). The ARV of each Weekly Prize is \$750.
- C. Total ARV:** The total ARV of all prizes (each, a “Prize”) available in the Sweepstakes is \$16,000.
- D. Odds of Winning:** The odds of winning a Weekly Prize depend on the total number of eligible entries received during each Entry Period. The odds of winning the Grand Prize depend on the total number of eligible entries received during the Sweepstakes Period.
- E. General:** In no event will more than the above numbers of Prizes be awarded. If, for any reason, more Prize notifications are sent (or more claims are received), Sponsor reserves the right to award a Prize through a random drawing from among all eligible Prize claims received. No Prize substitution or exchange will be allowed, except by Sponsor, as provided herein. A winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes. All other costs and expenses not expressly set forth herein shall be solely a winner’s responsibility. The Sweepstakes Entities shall not be held responsible for any delays in awarding a Prize for any reason. If after a good-faith attempt Sponsor is unable to award or deliver a Prize, the Prize may not be re-awarded.
- 6. HOW TO CLAIM A PRIZE:** Each potential winner is subject to verification of eligibility and compliance with these Official Rules. LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; or (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. DISPUTES:** THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF MICHIGAN, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN THE OAKLAND COUNTY, MICHIGAN. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
